DEPARTMENT:

Village of Enosburg Falls Electric Light Department

GENERAL STATEMENT OF DUTIES & RESPONSIBILITIES:

Performs routine and specific construction, maintenance and repair activities for the electric generation and distribution facilities of the Village of Enosburg Falls Electric Light Department.

SPECIFIC DUTIES & RESPONSIBILITIES:

- Performs daily inspection of all plant equipment and performs all maintenance as instructed.
- Construction and maintenance of distribution circuits.
- Installs and maintains underground primary and secondary conductors.
- Works on 2.4, 7.2 and 12.4kv conductors, energized when necessary.
- Performs Right of Way clearing and maintenance, to include brush clearing and tree trimming.
- Completes detailed work reports on all tasks performed.
- Oversees and coordinates "on the job" training for lesser grade "line technician in training".
- Operates Village hydro and diesel generating facilities.
- In the absence of the Head Line Technician directs the line crew.
- Performs other tasks as assigned by the Crew Leader of the Electric Department.
- Adheres to OSHA, VOSHA, and other safety regulations
- Follows and maintains certification of Vermont Work Zone Traffic Control Flagger Regulations

PHYSICAL REQUIRMENTS:

- Work during varied conditions
- Standing for long periods of time
- Walking for long periods of time
- Ability to lift and carry a minimum of 50 pounds
- Pushing and Pulling
- Reaching overhead
- Use of Hand, foot and/or leg controls (*to operate machinery or equipment – to include, but not limited to, pedals, buttons, levers, and cranks*)
- Driving
- Stooping, crouching, kneeling, and crawling

- Climbing ramps/stairs
- Climbing ladders and poles

SUPERVISION RECEIVED:

Works under the direct guidance of the Crew Leader of Village of Enosburg Falls Electric Light Department, in his/her absence, the Village Manager. Must be able to work independently and under certain circumstances without direct supervision.

SUPERVISION EXERCISED:

Lesser class line technician, apprentices, utility worker, laborers and other workers as assigned by, or in the absence of, the Crew Leader of Village of Enosburg Falls Electric Light Department.

QUALIFICATIONS:

- High School graduate.
- Must possess a Commercial Driver’s License with all proper endorsements.
- Experience as a Class “A” Line Technician and must possess a Vermont Line Technicians Certification.
- Must be able to expend considerable physical effort such as lifting, pulling, and carrying of heavy objects under varied conditions.
- Telephone at residence.
- Knowledge of OSHA, VOSHA and other safety regulations pertaining to the operation of equipment and construction and maintenance activities described.
- Working knowledge, experience and training in the construction, operation, and maintenance of 2.4, 7.2 and 12.4kv distribution systems and the knowledge and experience in working on such while energized.
- Must be able to work independently and in certain circumstances without direct supervision.

TERMS OF EMPLOYMENT:

- Must always maintain a good character profile with the public during all working hours while performing any assigned duties.
- Must be able to meet and deal with the public.
- Must have the ability to cooperate and establish effective working relationships with co-workers and supervisors.
