FAQs

1. What types of heat pump technology are eligible for an incentive?

- Ductless heat pumps
- Centrally ducted heat pumps
- Air-to-water heat pumps
- Ground source heat pumps

2. How much is the heat pump incentive?

The discount varies depending on the type and size of technology.

- Ductless heat pumps: \$250
- Centrally ducted heat pumps: \$750 \$1,500 (depends on size of the heat pump)
- Air-to-water heat pumps: \$1,000/ton
- Ground source heat pumps: \$2,100/ton
- **Weatherization adder:** Additional \$200 incentive for installing in a weatherized residential building. Stacks on top of all other incentives.
- Controls adder: Additional \$400 incentives from Efficiency Vermont for installing integrated controls. Stacks on top of all other incentives.
- Statewide income adder: Additional \$200 from Efficiency Vermont for all incomequalifying customers. Stacks on top of all other incentives.
- Tailored efforts income adder: Additional \$800 for income-qualifying customers of Enosburg, Johnson, & Orleans. Stacks on top of all other incentives.

3. How do I apply for the heat pump incentive and adders?

• **Ductless heat pumps:** No application. Work with a participating contractor. They will discount at least \$250 off the cost of the equipment at the time of purchase.



- **Ducted heat pumps:** No application. Work with a participating contractor. They will discount at least \$250 off the cost of the equipment at the time of purchase.
- Air-to-water heat pumps: Submit rebate application on Efficiency Vermont's website after the installation is completed.
- **Ground source heat pumps:** Submit rebate application on Efficiency Vermont's website after the installation is completed.
- Weatherization adder: Submit rebate application on VPPSA's website after the heat pump has been installed and weatherization work is completed. See question 5 for more details.
- Controls adder: Submit rebate application on Efficiency Vermont's website after the installation is completed.
- Statewide income adder: Submit rebate application on Efficiency Vermont's website after the installation is completed.
- Tailored efforts income adder: Submit rebate application on Efficiency Vermont's website after the installation is completed.

4. Which weatherization projects qualify for the \$200 Heat Pump + Weatherization Rebate?

- Completed a Home Performance with EnergySTAR
- Received weatherization through the Weatherization Assistance Program since 2005 or are currently enrolled
- Received a 2011 or newer Residential Building Energy Standards (2011 RBES) certificate
- Had a blower door test performed with a maximum measured Air Changes per Hour (ACH) of less than 5 at 50 Pascals

5. How do I apply for the \$200 Heat Pump + Weatherization Rebate?

- 1. Visit www.vppsa.com/rebates
- 2. Click "2023 Cold Climate Heat Pump Technology Instant Discount"
- 3. Click the "Apply Online" button. Alternatively, scroll down and click "Download the rebate application form."
- **4.** Complete the rebate application according to the instructions and submit with supporting documentation.

6. I did some DIY weatherization (attic insulation, windows replaced, etc.). Does that qualify for the \$200 Heat Pump + Weatherization Rebate?

Only if you did a blower door test afterwards and the results show less than 5 ACH at 50 Pascals.



Heat Pump Water Heaters

All heat pump water heaters installed by a participating contractor are eligible for an instant discount. If you installed the heat pump yourself, you can receive a post-purchase rebate.

FAQs

1. How do I apply for the heat pump water heater incentive?

There are two ways to receive the incentive:

- 1. **Instant Discount:** No application. Work with a participating contractor and receive a \$600 discount at the time of purchase. You can find a list of participating contractors at www.EfficiencyVermont.com
- 2. **Post-Purchase Rebate:** Purchase an eligible heat pump and install it yourself or with a non-participating contractor. Fill out and submit the rebate form. Rebate form can be found here: https://rebates.efficiencyvermont.com/evt/home

2. How much is the heat pump water heater instant discount?

\$600. Low-to-moderate income households can apply for an additional \$200 on Efficiency Vermont's website.

3. Is there a separate VPPSA rebate form I need to fill out?

No. There is no separate VPPSA rebate form for the heat pump water heater discount.

2. How much is the electric vehicle/plug-in hybrid rebate?

• New Electric Vehicle: \$1,000 (+\$400 for income-qualifying)

• New Plug-In Hybrid: \$500 (+\$400 for income-qualifying)

Used Electric Vehicle: \$500Used Plug-In Hybrid: \$250

3. Does it matter if I buy or lease?

No. The incentive does not change depending on whether you buy or lease.

4. Are there other incentives I'm eligible for?
