1. Modifications/Changes to Agenda

2. Public Comment

3. Review/Approve Regular Meeting Minutes May 23rd, 2023.

5. Sherri Underwood request for water/wastewater allocation for 104 Maple Park

6. Sign off on State revolving loan for Church Street Sewer
The paperwork for the Church Street sewer project was reviewed and signed off on by the Trustees.
7. Jesse – Zoning to discuss food trucks and animal ordinance.
It was decided to move this discussion to the executive session.
8. ATV's – follow up discussion on ATV use in the Village.
Discussion centered around potential routes for ATVs to have access to gas stations and restaurants within the Village limits. There were discussions for both sides, for and against allowing access. The Trustees asked VASA to put together proposed routes and for VASA to see if they could find access with private landowners to Parkside rather than Village roads. The Trustees will put this back on the agenda for July.
