2. Public Comment

9. Quincy Hotel Variance for Wastewater

Village Manger John Dasaro advised that it was determined that there was not a need for a pump station, that there is enough of a gravity fed and they will bypass the grease trap. 10. ARPA funds utilized to pave Maple Park

Village Manager John Dasaro gave an update on the Church Street and Maple Park sewer project, advising that Maple Park was in such disarray that they were not able to just do an overlay and had to pave the road in its entirety. ARPA money had already been allocated to pave Maple Park and would be used to fund the balance.

11. Manager's Minutes

- Elm Street Update the test pits have been cold patched
- Lead Inventory Update We are gaining significantly in how many have been completed. A new flyer is being left asking for the remaining customers to assist by taking pictures and sending them in.
- 32 Main and 24 Main Street Tear Down the asbestos abatement was done today; demolition should start in the next couple of weeks. Still waiting to close on 32 Main Street.
- Village Designation is complete.
- HMP (Hazard Mitigation Plan) is still in the works and should be completed soon, we are working with NRCP. This plan is crucial to receive FEMA funding.
- Speed bumps signage. Holding off on Pleasant Street for now, but Orchard and Water Tower Road bumps are in. 2-hour parking signs are going up in the next couple of weeks.

12. Other Business

Sam Vaillancourt shared that the Village has received the 2023 Community Fluoride award! Great job to the Water Department.

Abbey Miller gave an update on the NISC software conversion and updated the price and to make sure the Board still supported moving forward, they do.

Abbey also updated the Board on the VCDA Spring Conference that she attended that day regarding economic development and opportunities for the Village to review.

Heather Moore shared that the Enosburg Youth Center received another \$45,000.00 grant from the United Way!
