There will be a bid opening for this project, all bids will be opened and reviewed at the Village Office on, July 27th 3:00 P.M.. The awarded contractor will be notified after review at the Village's trustees meeting on July 28th.

LOCATION: The Kendall Building is located at 42 Village Dr, Enosburg Falls, VT 05450 adjacent to Rt 108 bridge in Enosburg Falls.

TYPE OF CONSTRUCTION: The Village is seeking a contractor - Work to be performed under this project includes – 1. Replacement of five historic windows to historical preservation specifications at 38" x 69", including the disposal of old windows. 2. Build storm windows that can be used temporarily in the wintertime for energy efficiency. The window frames are an estimated 103"x57", three of these and one 63"x44.
